And they have requested us to bind them with the bonds of matrimony, having confirmed the inexistence of any impediments to their marriage, and the witnesses attesting thereto.

And after verifying the inexistence of any legal impediment to their marriage, and verifying that the wife ~~has~~ / hasn't a governmental salary or wage or that she ~~is a minor~~ who ~~has~~ / hasn't an amount of money exceeding two hundred pounds, and after the couple stated before us and before the attendees their consent to this marriage (yes). The marriage took place on Thursday July 30, 1981 [illegible] Michael Shnouda minister of the Church of The Martyrs St. Abo Sefein and St. Demiana.

And as this marriage has been announced with no person coming forward with an objection thereto (no).

And we asked the applicants whether they have elected a certain matrimonial financial system, and each replied: NO

And they stated that the husband has paid a dowry or wedding ring of which the value is: 100 Egyptian pounds

And we have also asked whether any of them had previously been married and to whom: NO

The husband replied: No. and the wife replied: No.

Hence we have publicly explained to them, before the attendees, the effects of this marriage, then we asked the husband whether he agrees to marry (the wife) who was present at the contract meeting, as his lawfully wedded wife, and he replied by saying: YES, then we asked the wife whether she agrees to marry (the husband) who was present at the contract meeting, as her lawfully wedded husband, and she replied by saying: YES

Therefore we have declared before the attendees that they have become bound by the bonds of proper lawful marriage, after completing all religious ceremonies as confirmed by the Patriarchate / ~~Archdiocese~~ certificate no. 903/36 dated 7/24 year 1981.

In accordance to the above, this contract has resulted in the lawful marriage of (husband and wife) [REDACTED] and after reading it before the attendees and witnesses, all have signed upon it with us.

Instructions

- 1- The hour, day and date shall be stated in numbers and words.
- 2- If documentation is in the church, it would be sufficient to state the name of the documenter, church and its affiliation, and if documentation is outside the church, then state its place and address.
- 3- State the first and last name of the husband and wife, as well as their nationality, occupation, date and place of marriage and residence. Also state first and last name and nationality, occupation and residence of their parents. Also state the parents' consent if they or any of them attended the contract documentation or if someone on their behalf attended, such as a guardian or custodian – and if no one attended, the official certificate shall state such consent.
- 4- State the date of publication and place thereof if the required by the laws of both or any of the couple.
- 5- The financial arrangement agreed upon by the couple shall be stated, as well as the date of the certificate issued with respect thereto, and the entity before which it was issued, and attach it to the contract.
- 6- If the wife has a pension or government salary, it shall be stated in the form, and in such case the relevant party must be informed. Also in this case and in case the wife was a minor with more than two hundred pounds, there must be an approval of marriage by the relevant Personal Affairs Court.
- 7- The appointed documenter may add the Coptic date if requested.
